### Applicable Penalties

1. A person who fails to provide the particulars of the Beneficial Owner(s) or provides false or misleading information to the Registrar shall be liable to:
  - a. A fine of not less than one hundred and fifty penalty units and not more than two hundred and fifty penalty units or;
  - b. A term of imprisonment of not less than one year and not more than two years or to both
2. Where a company defaults in complying with this section, this company and every officer of the company shall be liable to pay an administrative penalty of twenty-five penalty units for each day during which the default continues
